St. Louis, Michigan December 5, 2023

The regular meeting of the Saint Louis City Council was called to order by Mayor Thomas L. Reed on Tuesday, December 5, 2023 at 6:00 p.m. in the City Hall Council Chambers.

City Council Minutes.

Resolution 2023-24-Gratiot County Parks Grant Application.

After discussion, the following preamble and resolution were offered by Member Palmer, and supported by Member Upton:

WHEREAS, the City of St. Louis has the authority to construct, operate and maintain the North Street Landing; and

WHEREAS, the City of St. Louis is requesting a \$73,500 appropriation from the Gratiot County

Board of Commissioners; and

WHEREAS, the City of St. Louis desires to enhance, provide or create the North Street Boat Launch to meet the needs of users in Gratiot County;

THEREFORE LET IT BE RESOLVED by the City of St. Louis that, pursuant and subject to all of the terms and provisions of the Gratiot County Parks millage, application be made to the Gratiot County Board of Commissioners for funding; and

BE IT FURTHER RESOLVED that Kurt Giles, the City Manager of the City of St. Louis is hereby authorized and directed to cause the necessary data to be prepared and application be signed and filed with the County of Gratiot;

Resolution 2023-25-Temporary Suspension of the Joe Scholz Memorial Fishing Derby.

Discussion was held, including more audience comments.

The following preamble and resolution were offered by Member Upon, and supported by Member Palmer:

WHEREAS, Event founder and former Mayor Joe Scholtz began organizing a free fishing derby in 1999 which has been held annually on the second Saturday of June to coincide with Free Fishing Weekend in Michigan; and

WHEREAS, Following Joe Scholtz' passing in 2011, the annual event was renamed the Joe Scholtz Memorial Free Fishing Derby and his work was continued by volunteer organizers to hold the event nearly every year since that time; and

WHEREAS, the City Council of the City of St. Louis understands Joe Scholtz' motivation for organizing the event was to raise awareness of the condition of the Pine River and the necessity of the highest quality environmental remediation of the river and adjacent lands in the St. Louis area and to promote outdoor sporting activities, especially among our youth; and

WHEREAS, Over the years, the City Council and Staff have been continually supportive of the Free Fishing Derby and the ideals and goals that Founder Joe Scholtz had when the event was started; and

WHEREAS, In recent years, there has been evidence of increased algal blooms, excessive nutrient and elevated e-coli levels in waters of the St. Louis area of the Pine River and these e-coli levels have sometimes exceeded the safe threshold for human contact as determined by the Michigan Department of Health and Human Services; and

WHEREAS, Along with the current organizers of the Joe Scholtz Memorial Fishing Derby, the St. Louis City Council has concerns over a public event where activities may lead to harmful effects on the health and safety of its participants.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the City Council of the City of St.

Louis is supportive of a decision to temporarily suspend the organized event known as the Joe Scholtz Memorial Free Fishing Derby for calendar year 2024 by cancelling the event which would have been held on June 8, 2024.

Presentation by Steve Donkersloot of the MPPA and Michael McGeehan of GRP Engineers Regarding the Solar Project.

Elizabeth Upton was excused from the meeting at 8:00 p.m.

Approval of Interconnection and Power Purchase Agreements for SolAmerica Distributed Energy Project/Resolution 2023-26.

The following preamble and resolution were offered by Member Palmer, and supported by Member Leonard:

WHEREAS, the City of St. Louis, County of Gratiot, State of Michigan (the "City") has a continual interest in projects and power supply opportunities that will improve its ability to provide safe, reliable, and cost-effective electric service to its customers; and

WHEREAS, through its membership with the Michigan Public Power Agency (MPPA), the City has been in collaboration with St. Louis MI Affordable Solar, LLC (SLMAS) in the development of a 1.2 Megawatt (MW) solar generating facility located in Bethany Township which is proposed to have an interconnection with the City's electric distribution system; and

WHEREAS, SLMAS has secured the rights for use of at least one viable parcel of land for siting the 1.2 MW solar photovoltaic (PV) distributed energy resource (DER) for a period of not less than 25 years; and

WHEREAS, MPPA members including the City have had impact studies performed by GRP

Engineering to determine if the proposed interconnection with the City's distribution system would result in adverse impacts on the City's system or its customers and GRP's study has concluded that, with the proposed system upgrades, there will be no adverse impacts; and

WHEREAS, parties including the City, MPPA, GRP Engineering and SLMAS have reviewed and negotiated a proposed Interconnection Agreement (IA) with mutually acceptable terms; and

WHEREAS, parties including the City, MPPA and SolAmerica and respective legal counsel have reviewed and negotiated the terms of a proposed Power Purchase Agreement (PPA) with mutually acceptable terms; and

WHEREAS, MPPA staff has performed a mark-to-market analysis of the financial terms of the proposed PPA and, along with being a desirable addition to the City's energy portfolio,

finds the proposed cost to be favorable to the City over the term of the PPA; and

WHEREAS, SLMAS has successfully completed the first round, letter of interest process with the United States Department of Agriculture (USDA) Powering Affordable Clean Energy (PACE) loan/principal forgiveness program and has been invited to submit a final application by no later than December 15, 2023; and

WHEREAS, part of the final application requirements for USDA are that the terms of the applicable agreements have been successfully negotiated however, not yet entered into since the DER Solar Project is dependent on USDA funding:

NOW, THEREFORE, BE IT RESOLVED THAT: the St. Louis City Council does hereby authorize the City Manager or designee and the City Clerk to execute the IA and PPA associated with the 1.2 MW Solar DER Project located in Bethany Township, subject to SLMAS receiving the project loan/principal forgiveness from USDA and the final form of the IA and PPA having no material changes from the versions presented on December 5, 2023 upon review of MPPA, legal counsel and the City.
