### **INFORMATION FOR ALL CRIME VICTIMS**

- 1. If you would like to be notified of an arrest in your case, you should call the law enforcement agency indicated on the back of this brochure and inform them.
- 2. If you are not notified of an arrest in your case, you may call the law enforcement agency indicated on the back of this brochure for the status of the case.
- 3. You may be eligible for crime victim compensation benefits. To apply, contact the Crime Victim Services Commission at (517) 373-7373 or (877) 251-7373 and request an application.
- 4. If you have questions regarding your rights as a crime victim, you should call the Gratiot County Prosecutor's Office at (989) 875-5236 and ask to speak with Jan Donley, Crime Victim Coordinator.
- 5. You may obtain a copy of your police report by contacting the Gratiot County Prosecutor's Office at (989) 875-5236.

### INFORMATION FOR VICTIMS OF DOMESTIC VIOLENCE

Your legal rights include the right to go to court and file a petition requesting a Personal Protection Order (PPO) to protect you and/or other members of your household from domestic abuse which could include restraining or enjoining the abuser from doing the following:

- Entering onto property where you live.
- Assaulting, attacking, beating, molesting, or wounding you.
- Removing minor children from you, except as otherwise authorized by a custody or parenting time order issued by a court of competent jurisdiction.
- Engaging in stalking behavior.
- Interfering with your efforts to remove your children or personal property from premises that are solely owned or leased by the abuser.
- Threatening to kill or physically injure you or another person.
- Interfering with you at your place of employment or education or engaging in conduct that impairs your employment relationship or your employment or educational environment.
- Engaging in any other specific act or conduct that imposes upon or interferes with your personal liberty or that causes a reasonable apprehension of violence.
- Having access to information in records concerning any minor child you have with the abuser that would inform the abuser about your address or telephone number, the child's address or telephone number, or your employment address.
- Purchasing or possessing a firearm.

Your legal rights also include the right to go to court and file a motion for an order to show cause and a hearing if the abuser is violating a PPO and has not been arrested.

### INFORMATION FOR VICTIMS OF SEXUAL ASSAULT

- 1. You can have a sexual assault medical forensic examination and have evidence collected using a sexual assault evidence kit even if you do not want to participate in the criminal justice system or cooperate with law enforcement.
- 2. You cannot be billed for the cost of administrating the sexual assault evidence kit. If you receive a bill for these services, contact the Michigan Crime Victim Services Commission at (517) 373-7373.
- 3. You have the right to ask the investigating law enforcement agency for the contact information for the detective or investigating officer assigned to the case, the current status of the case, whether the case has been submitted to the prosecuting attorney for review, and whether the case has been closed and the documented reason for closure.
- 4. If you had a sexual assault evidence kit collected and released to law enforcement, you have a right to ask the investigating law enforcement agency for the following information: when the sexual assault evidence kit was sent to a forensic laboratory for testing; whether a DNA profile was obtained from the sexual assault evidence kit; whether a DNA profile was entered into The Combined DNA Index System (CODIS); and whether a DNA profile resulted in a CODIS hit.
- 5. Your legal rights include the right to go to court and file a petition requesting a Personal Protection Order (PPO) to protect you from the offender. The PPO could order the offender not to have contact with you and could include other specific conditions.
